RESOLUTION NO. 34

A RESOLUTION FORMALLY ACCEPTING THE DONATION OF ISLA VERDE
CABLE BRIDGE BY THE KIWANIS CLUB OF METRO ORMOC, INC.
INSTALLED AT SITIO ISLA VERDE, BARANGAY 26, THIS CITY, PER
DEED OF DONATION, DATED MARCH 10, 1984.

"WHEREAS, there is now being installed Isla Verde Cable
Bridge at Sitio Isla Verde connecting to the highway, a project
undertaken by the Kiwanis Club of Metro Ormoc, Inc.

"WHEREAS, on March 10, 1984 the Kiwanis Club of Metro Ormoc,
Inc. executed a Deed of Donation of same date signed by its Club
President and Secretary, respectively, turning over the Isla Verde
Cable Bridge to the City Government of Ormoc;

"WHEREAS, the Sitio Isla Verde Barangay 26 Officials in its

assistance or any aid whatsoever without any formal acceptance of
same;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, seconded by
Kagawad Hermosilla; be it

Cable Bridge installed at Sitio Isla Verde of Barangay 26, this
city, per Deed of Donation dated March 10, 1986, signed by its
Club President and Secretary, respectively, and expressing our
heartfelt thanks and gratitude to the Club for their worthy dona-
tion as a civic contribution to the improvement of the livelihood
of the people of Isla Verde, Barangay 26, this city.


