RESOLUTION NO. 43

A RESOLUTION COMMITTING THE CITY GOVERNMENT OF ORMOC TO APPROPRIATE P30,000.00 AS COUNTERPART FOR THE OPERATION AND MAINTENANCE OF ORMOC PIER FOR FISCAL YEAR 1987 IN COORDINATION WITH THE PROPOSED IMPROVEMENT THEREON AS ENVISIONED IN THE PROPOSED MPWH 1987 INFRASTRUCTURE PROGRAM.

"WHEREAS, the Ministry of Public Works and Highways makes a ruling that in order the city government could be included in the 1987 Infrastructure Program of the ministry, they must submit a written commitment carrying with it an appropriation in the amount of P30,000.00 as counterpart of the City of Ormoc to be incorporated in its annual budget for the operation and maintenance of the pier after which improvement/construction shall have been finished;

"WHEREAS, the Honorable Minister of the Ministry of Public Works and Highways, in his Memorandum dated June 26, 1986, addressed to all MPWH Regional Directors, among others, directing for a second draft of the Proposed 1987 MPWH Infrastructure Program to update the list of projects of the regions of which Ormoc City is one based on the increased tentative budgetary ceilings as established by the MPWH funds allocation formulae;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, seconded by Kagawad Sumaljag; be it

"RESOLVED, to commit the city government of Ormoc to appropriate P30,000.00 as counterpart for the operation and maintenance of Ormoc pier for fiscal year 1987 in coordination with the proposed improvement thereon as envisioned in the proposed MPWH 1987 Infrastructure Program;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Honorable Rogarciano M. Mercado, MPWH Minister, Metro Manila, the Regional Director, MPWH, Paving, Palo, Leyte; and the City Engineer, Ormoc City;

"CARRIED UNANIMOUSLY."
