RESOLUTION NO. 45

A RESOLUTION TO REDUCE THE MONTHLY RENTAL OF THE SHOPPING MALL GROUND FLOOR STALLS FROM P1,750.00 PER STALL TO P1,300.00 PER STALL UP TO DECEMBER 31, 1986 FOR THOSE ON YEARLY CONTRACT ONLY, EXCEPT MERCURY DRUG STORE, RETROACTIVE FEBRUARY 1, 1986, PROVIDED, HOWEVER, THAT THEY HAVE UPDATED THEIR OBLIGATIONS TO THE CITY.

"WHEREAS, this august Body has received a Petition dated May 7, 1986 from some stallholders of the Shopping Mall ground floor asking a reduction of their monthly rental from P1,750.00 per stall to P1,250.00 per stall;

"WHEREAS, after due consideration on the matter, the august Body is of the consensus that instead of P1,250.00 that the stallholders were asking for, it should be P1,300.00;

"NOW, THEREFORE, on motion of Kagawad-Floor Leader Yrastorza, seconded by Kagawad Suan; be it

"RESOLVED, to reduce the monthly rental of the Shopping Mall ground floor stalls from P1,750.00 per stall to P1,300.00 per stall up to December 31, 1986 for those on yearly contract only, except Mercury Drug Store, retroactive February 1, 1986, Provided, However, that they have updated their obligations to the city;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, and the Stallholders concerned, all in Ormoc City.

"CARRIED. Eight affirmative votes. One abstension registered by Kagawad Hermosilla.
