RESOLUTION NO. 46

A RESOLUTION AUTHORIZING THE HONORABLE EMBETERIO V. LARRAZABAL
TO ISSUE LICENSE TO THE MACABUG COCKPIT FOR PURPOSES OF
THEIR REQUIREMENTS FOR THE REGISTRATION WITH THE PHILIPPINE
GAMEPOWL COMMISSION.

"WHEREAS, this august Body is in receipt of the communication of the
Manager, Macabug Cockpit, dated July 21, 1986 informing, among others,
that they have already applied with the Philippine Gamefowl Commission
for a Certificate of Registration of said cockpit, and one of the require-
ments therefor is the submission of a City License to be issued by the
City Mayor with the concurrence of the Sangguniang Panlungsod as provided
for under Section 10 of the Rules and Regulations promulgated by the Com-
mission;

"NOW, THEREFORE, on motion of Kagawad Suan, seconded by Kagawad
Rivilla; be it

"RESOLVED, to authorize the Honorable Embeterio V. Larrazabal to
issue license to the Macabug Cockpit for purposes of their requirements
for the registration with the Philippine Gamefowl Commission, as provided
for under Section 10 of the Rules and Regulations promulgated by the Phi-
lippine Gamefowl Commission.

Station Commander, Integrated National Police, and the Manager, Macabug
