RESOLUTION NO. 48

A RESOLUTION EARNESTLY REQUESTING THE LTC REGIONAL DIRECTOR TO REINSTATE MR. ROBERTO COSTELO, TRANS-PORTATION DISTRICT SUPERVISOR III AS REGULAR RE-GISTRAR OF OMMOC CITY LTC AGENCY PER PLANTILLA POSITION INCLUDING EMPLOYEES HOLDING ITEMS FOR ORMOC WHO ARE DETAILED IN OTHER AGENCIES AND TO RETURN ALL EMPLOYEES WHO ARE AT PRESENT DETAILED IN ORMOC CITY LTC AGENCY BACK TO THEIR OFFICIAL STATIONS.

"WHEREAS, it has been the practice of the past administration to reshuffle employees by detailing them to agencies far from their official station and designating Officer-In-Charge with lower ranks in place of regular heads of offices thereby greatly affecting the efficiency of the service;

"WHEREAS, Ormoc City LTC Agency is undermaned, being agency with an annual collection of TWO MILLION NINE HUNDRED THOUSAND PESOS (#2,900,000.00) plus, it deserves to have its Regular Registrar who is a Transportation District Supervisor III as Head of Office;

"WHEREAS, there is a petition signed by the Drivers Association and Motor Vehicle Operators of Ormoc City requesting the removal from Ormoc City of the present Officer-In-Charge;

. "NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Kagawads Sumaljag and Hermosilla; be it

RESOLVED, to earnestly request the Honorable Director LTC Region VIII, to reinstate Mr. Roberto Costelo, Transportation District Supervisor III as Regular Registrar of Ormoc City LTC Agency per plantilla position including all employees holding items for Ormoc who are detailed in other agencies and to return all employees who are at present detailed in Ormoc City LTC Agency back to their official stations.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Col. Mariane Santiago, Officer-In-Charge, Land Transpertation Commission, East Avenue, Quezon City and to the Di-rector, Land Transportation Commission, Region VIII Tacleban City;
