RESOLUTION NO. 49

A REOSLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE AMOUNT OF \$1,155.00 FROM OUT OF THE 10% BARANGAY SHARE OF MARGEN TO BE MADE AVAILABLE FOR THE PURCHASE OF SEVEN (7) . SETS OF FLOURESCENT LIGHTING FIXTURES OF 20-WATT, 220 VOLTS, WITH WEATHER PROTECTOR AND MOUNTING ATTACHMENTS AND AUTHORIZING THE HONORABLE, OFFICER IN-CHARGE, CITY MAYOR'S OFFICE TO ACCEPT THE DOWATION OF THESE ITEMS, SUBJECT, HOWEVER, TO RESOLUTION NO. 1149, SERIES OF 1982.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Hermosilla. seconded by Kagawad Sumaljag; be it

"RESOLVED, to authorize the City Treasurer to release the amount of One Thousand One Hundred Fifty-Five Pesos (P1,155.00) from out of the 10% Barangay share of Margen, said sum or so much thereof as may be necessary to be made available for the purchase of seven (7) sets of flourescent lighting fixtures of 20-watt, 220 volts, with weather protector and mounting attachments and authorizing the Honorable Officer In-Charge, City Mayor's Office to accept the donation of these items, subject, however, to Resolution No. 1149, series of 1982, limiting barangay electric current to only 250-watt, otherwise, any excess of wattage will be paid by the barangay out of their 10% realty tax shares.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, and the Sangguniang Pambarangay of Margen, all in Ormoc City;
