RESOLUTION NO. 5

A RESOLUTION AMENDING SECTION 2 OF RULE V OF RESOLUTION NO. 804, S. 1980, (RULES AND PROCEDURES OF THE SECOND SANGGUNIANG PANLUNGSOD NG ORMOC) ADOPTING WEDNESDAY OF THE WEEK AS THE REGULAR SESSION DAY OF THE THIRD SANGGUNIANG PANLUNGSOD NG ORMOC TO COMMENCE THIS COMING WEDNESDAY MAY 28, 1986 at 9:30 A.M.

WHEREAS, Section 14 of Republic Act 179, as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, provides that the Municipal Board now Sangguniang Panlungsod ng Ormoc should hold its regular session for transaction of business at least once a week;

WHEREAS, this august Body finds Wednesday the best day to hold its regular session;

NOW, THEREFORE, on motion of Kagawad Rivilla seconded by Kagawad Suan; be it

RESOLVED, to amend Section 2 of Rule V of Resolution No. 804 s. 1980 (Rules and Procedures of the Second Sangguniang Panlungsod ng Ormoc), so that Section 2, of Rule V would now read;

Section 2. Time. The regular session shall be held at the session hall of the City Sangguniang to commence at 9:30 in the morning every Wednesday beginning May 28, 1986 and may end at such time as the Body may agree.

RESOLVED, FURTHER, to furnish a copy of this resolution, each to His Honor, the Officer In-Charge, City Mayor's Office, the Honorable OIC, Office of the Vice-Mayor & Presiding Officer, and the Honorable Kagawads of the Sangguniang Panlungsod ng Ormoc, all Department Heads, Local and National, and all Barangays, all in Ormoc City;
