RESOLUTION NO. 55

A RESOLUTION COMMENDING THE VARIOUS MILITARY UNITS, OFFICERS AND  
MEN FOR THEIR EXEMPLARY SERVICES IN THE PLANNING, ORGANIZATION  
AND IMPLEMENTING OF SECURITY MEASURES DURING THE 1986 ORMOC  
CITY FIESTA.

"WHEREAS, the Ormoc City Fiesta '86 was celebrated peacefully without  
a slightest violation of laws and ordinances against persons and property;

"WHEREAS, the Philippine Army through the 8th Regional Community De-  
fense Unit, 8th Infantry Brigade (Separate) Philippine Army was responsible for
