ARNULFO I. GARCIANO, POLICE STATION COMMANDER; MISS CONCHITA OCUBILLO; MR. EDGAR DE LOYOLA; MR. BIENVENEDO LAGADO; AND MR. SIXTO PONGOS, AS MEMBERS, SUBJECT, HOWEVER, TO THE APPROVAL OF THE MOVIE AND TELEVISION REVIEW CLASSIFICATION BOARD, MANILA.
