RESOLUTION NO. 64

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST THE
IMPROVEMENT OF ORMOC CITY WATERWORKS UNDER THE INFRASTRUCTURE
FUND THE SUM OF FIVE THOUSAND EIGHT HUNDRED FIFTY PESOS (P5,850.00)
TO BE MADE AVAILABLE FOR THE PURCHASE OF THIRTY (30) PCS. G.I.
PIPES #1 FOR REPAIR OF OLD AND DESTROYED PIPES, TO BE UTILIZED
AS PIPING LINE FOR WATER SUPPLY TO THE SCHOOL OFFICES AND PREMISES
OF THE MAS-IN COMMUNITY SCHOOL AND ENTIRE BARANGAY MAS-IN, THIS
CITY.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Sumaljag,
seconded by Kagawad Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to charge against the Improve-
ment of Ormoc City Waterworks under the Infrastructure Fund the sum of Five
Thousand Eight Hundred Fifty Pesos (P5,850.00) said sum or so much thereof as
maybe necessary to be made available for the purchase of thirty (30) pcs. G.I.
pipes #1 for repair of old and destroyed pipes, to be utilized as piping line
for water supply to the school offices and premises of the Mas-in Community
School and entire Barangay Mas-in, this city;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the
City Treasurer, the City Budget Officer, the City Engineer and the Sangguni-
ang Pambarangay of Mas-in, all in Ormoc City;
