RESOLUTION NO. 65

A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY, PRESIDENT
CORAZON C. AQUINO THRU THE HONORABLE MINISTER OF EDUCATION
CULTURE & SPORTS, LOURDES QUISUMBING, FOR THE CONSTRUCTION
OF A NEW ORMOC CITY CENTRAL SCHOOL BUILDING WITH 40 STAND-
DARD CLASSROOMS.

"WHEREAS, the then Second Sangguniang Panlungsod ng Ormoc having
passed Resolution Nos. 1084 on December 1, 1981, followed up with Reso-
lution No. 1218 on August 24, 1982 and Resolution No. 1347 on March 22,
1986, respectively, earnestly requesting the higher authorities con-
cerned for the replacement of the old and dilapidated two-story 40-room
Ormoc City Central School building of 1947 vintage for the ultimate
safety of the teachers and school children thereof;

"WHEREAS, we would like to state the assessment of the survey con-
ducted by the City Engineer's Office that the Ormoc City Central School
is quite dilapidated and unfit for prolonged use and that repair would
be useless and would only be a waste of money since all the main struc-
tures are rotten, such that we dread the day that the building might co-
llapse in even a very slight tremor and claim hundreds of lives among
school teachers and children such that an immediate replacement of said
building becomes imperative;

"WHEREAS, we most humbly would like to turn our needs to Her Exce-
llency, President Corazon C. Aquino, who we believe, kindly understand
our discreet needs being the President of the Philippines, for immediate
replacement of the dilapidating Ormoc City Central School building by
way of financial assistance in the amount of P'9,000,000.00;

"NOW, THEREFORE, on motion of Kagawad Subingsubing, jointly seconded
by Kagawad Suan and Fiel; be it


"RESOLVED, to earnestly request Her Excellency, President Corazon C. Aquino thru the Honorable Minister of Education, Culture & Sports, Lourdes Quisumbing, for a financial assistance of NINEMILLION PESOS (P 9,000,000.00) for the construction of a New Ormoc City Central School building with 40 standard classrooms;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Her Excellency, President Corazon C. Aquino, Malacañang, Hon. Lourdes Quisumbing, MECS Minister, both of Metro Manila; the Regional Director MECS Tacloban City; and the Division Superintendent of Schools, Ormoc City;

"CARRIED UNANIMOUSLY."
