RESOLUTION NO. 66

A RESOLUTION EARNESTLY REQUESTING THE PAL PRESIDENT, MR. DANTE SANTOS TO OPEN AT LEAST A BOOKING STATION IN ORMOC CITY IF CONNECTING PAL FLIGHTS CAN NOT BE AVAILABLE BETWEEN ORMOC-CEBU AND TACLOBAN-MANILA ROUTES.

"WHEREAS, there has been a clamor from the Ormoc City Consumers Association and the riding public to resume the Philippine Airlines connecting flight from Ormoc-Tacloban-Manila and Ormoc-Cebu-Manila routes;

"WHEREAS, on October 27, 1981 the Second Sangguniang Panlungsod ng Ormoc passed a Resolution No. 1057 petitioning to the Office of the President of the Philippines and to request Philippine Airlines, Inc. to resume its flight services to the City of Ormoc from its Cebu and Manila Stations in the interest of the residents of the City of Ormoc and of the industrial projects within its periphery, wherein volume of traffic is at this time more than sufficient to provide a substantial margin for the airline;

"WHEREAS, in response thereto Mr. Roman A. Cruz, Jr., Chairman of the Board and President, on February 8, 1982, among others, alleged that not all routes were productive and profitable as evidenced in the brief exposure they had in Ormoc, when they operated the 32-seater DC-3 during the period from January 1974 to January 1976, wherein they were only able to load an average of seven (7) passengers per flight in and out of Ormoc;

"WHEREAS, in the penultimate paragraph of same it states that as part of their marketing efforts, they were considering of establishing a booking office in Ormoc City, but until now no action has been made;

"WHEREAS, it is about time to make another resolution of same tenor for the good of public service in the communities;

"RESOLVED, to earnestly request Mr. Dante Santos, President of Philippine Airlines, Inc. to open at least a Booking Station in Ormoc City if connecting PAL flights can not be available between Ormoc-Cebu and Tacloban-Manila routes;


