GOVERNMENT OF ORMOC FOR THE USE OF CITY'S REHABILITATION CENTER.

"WHEREAS, no less than the Civic, Religious and Professional
organizations and the Ormoc City INP are helping hand in hand to bolster
the problems regarding batogs in Ormoc City;

"WHEREAS, as a result of this campaign there are many batogs
apprehended and temporarily housed in the Ormoc City Police
Headquarters;

"WHEREAS, these batogs are to be transferred any time if there is
a building for their accommodation;

"WHEREAS, there has been a campaign for rehabilitation of batogs
of the entire country;
