A RESOLUTION TO REALIGN THE PREVIOUS APPROPRIATION FOR
BARANGAY BANTIGUE WATERWORKS IMPROVEMENT IN THE AMOUNT
OF P450,000.00 FOR WATERWORKS INSTALLATION OF BARANGAY
VALENCIA AMOUNTING TO P80,000.00

"WHEREAS, this august Body passed and approved Resolution No. 22,
embodying Appropriation-Ordinance No. 86-6 (Infrastructure Fund) appro-
priating P795,500.00 of which Barangay Bantigue is one of the recipients
of said appropriation in the amount of P450,000.00 for its waterworks
improvement project;
