A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE
AGAINST CURRENT APPROPRIATION ON STREET ILLUMINATION
& LIGHTING FIXTURES OF THE INFRASTRUCTURE FUND THE
SUM OF TWENTY-TWO THOUSAND THREE HUNDRED FORTY-FOUR
PESOS (P22,344.00) TO BE MADE AVAILABLE FOR THE MANU-
FACTURE OF 144 PIECES OF ELECTRIC BULB HOLDER FOR
STREET LIGHTING.
