RESOLUTION NO. 74

A RESOLUTION AUTHORIZING THE HONORABLE EMETERIO V. LARRAZABAL, OFFICER-IN-CHARGE, CITY MAYOR'S OFFICE, TO ACCEPT THE DONATION OF TWELVE (12) UNITS FLUORESCENT LAMPS, 20 WATTS EACH OF 220 VOLTS, INSTALLED AT STRATEGIC PLACES IN BARANGAY ALTA VISTA, SUBJECT TO 250-WATT LIMITATION FOR EVERY BARANGAY, PER RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, the Sangguniang Pambarangay of Alta Vista in its Un-numbered Resolution, series 1986, has signified its intention to donate twelve (12) units street lighting fixtures, 20-watt, 220 volts, Fluorescent lights, installed in strategic places within Barangay Alta Vista, to the City Government for inclusion in the payment of power bills of 250-watt limits;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Yrastorza; be it

"RESOLVED, to authorize the Honorable Emeterio V. Larrazabal, Officer-in-Charge, City Mayor's Office, to accept the donation of twelve (12) units fluorescent lamps, 20 watts each of 220 volts, installed at strategic places in Barangay Alta Vista, subject to the 240-watt limitation for every barangay, per Resolution No. 1149 dated April 20, 1982;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the Sangguniang Pambarangay of Alta Vista, and the LEYECO V, all in Ormoc City;
