RESOLUTION NO. 77

A RESOLUTION GRANTING THE STO. NIÑO ARRASTRE AND STEVEDORING CORPORATION TO UNDERTAKE THE ARRASTRE WORK IN THE PORT OF ORMOC CITY.

"WHEREAS, this august Body is in receipt of a communication of the President, Sto. Niño Arrastre and Stevedoring Corporation, dated September 15, 1986, requesting that the operation of the arrastre to do the arrastre work in the port of Ormoc City be awarded to them;

"WHEREAS, Kagawad Antonio C. Sumaljag, Chairman, Committee on Labor manifested that by virtue of Administrative Order No. 13-77, the City of Ormoc has been declared as City Port, therefore it is not national and it is not within the purview of the Philippine Ports Authority, so that under this Administrative Order the City has the right to choose which Arrastre Operator is going to undertake arrastre work in our Port;

"WHEREAS, this august Body finds the request very reasonable and timely considering that we are still under the reorganization stage;

"NOW, THEREFORE, on motion of Kagawad Sumaljag, seconded by Kagawad Fiel; be it

"RESOLVED, to grant the Sto. Niño Arrastre and Stevedoring Corporation to undertake the arrastre work in the Port of Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Minister of Labor and Employment, Manila; the Regional Director, Ministry of Labor and Employment, Tacloban City; the President, Sto. Niño Arrastre and Stevedoring Corporation and New Eagle Arrastre Service, Inc., both in Ormoc City;
