RESOLUTION NO. 79

A RESOLUTION CREATING A COMMITTEE TO TAKE CHARGE OF THE DETERMINATION AND RELOCATION OF THE BOUNDARY OF ORMOC CITY AND KANANGA MUNICIPALITY INVOLVING THE BARANGAY OF TUNGONAN WHICH WAS ORIGINALLY A PART OF BARANGAY HIBMAON, ORMOC CITY, SAID COMMITTEE TO BE COMPOSED OF HONORABLE ARNULFO C. SALAZAR, AS CHAIRMAN; ATTY. DEMETRIO D. SARIT, AS CO-CHAIRMAN; MEMBERS: HON. ROMEO M. HERMOSILLA, KAGAWAD, ABC PRESIDENT; MR. JORGE L. SATORRE, JR., CITY ASSESSOR; MR. GODOFREDO A. SEVILLA, CITY TREASURER; ENGR. RUBEN C. PENSERGA, CITY ENGINEER AND ATTY. ARTURO P. SUAREZ, REGISTER OF DEEDS.

"WHEREAS, the residents of Barangay Tungonan, Ormoc City, where the Tungonan Geothermal Power complex is situated are at a loss whether they are under Ormoc City or Kananga, Leyte due to unclear boundaries;

"WHEREAS, said unresolved situation resulted in the following:

1. During elections the voters can not decide whether to vote in Ormoc City or Kananga, Leyte.
2. In civil and criminal cases, the litigants can not decide on the venue where to bring their suits.
3. Tax payers seldom pay or not at all their taxes because they can not determine where to pay their taxes.
4. A clash of interest looms regarding the collection of taxes from real estate owners and the PNOC considering that both Kananga municipality and Ormoc City lay claim to said collections.

"WHEREAS, it is imperative that a committee be created to determine and relocate the boundary of the Municipality of Kananga and Ormoc City as far as the barangay of Tungonan is concerned and to verify from the Philippine National Oil Corporation (PNOC) if they are paying their taxes to Ormoc City inasmuch as Kananga, Leyte is also claiming said taxes;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, duly seconded by Kagawad Subingsubing; be it

"RESOLVED, to create a committee to take charge of the determination and relocation of the boundary of Ormoc City and Kananga Municipality involving the Barangay Tungan which was originally a part of Barangay Hibunaon, Ormoc City, said committee to be composed of Honorable Arnulfo C. Salazar, as Chairman; Atty. Demetrio D. Sarit, as Co-Chairman; Members: Hon. Romeo M. Hermosilla, Kagawad, ABC President; Mr. Jorge L. Satorre, Jr., City Assessor; Mr. Godofredo A. Sevilla, City Treasurer; Engr. Ruben C. Penserga, City Engineer and Atty. Arturo P. Suarez, Register of Deeds;


"RESOLVED, FURTHER, to furnish a copy of this resolution each to Honorable Arnulfo C. Salazar and Romeo M. Hermosilla, SP Kagawads; Atty. Demetrio D. Sarit, City Legal Officer; Mr. Jorge L. Satorre, Jr., City Assessor; Mr. Godofredo A. Sevilla, City Treasurer; Engr. Ruben C. Penserga, City Engineer; and Atty. Arturo P. Suarez, Register of Deeds, all in Ormoc City and the Sangguniang Bayan of Kananga, Kananga, Leyte;


