RESOLUTION NO. 80

A RESOLUTION REQUESTING THE PHILIPPINE NATIONAL OIL COMPANY (PNOC) BASED IN TUNGONAN; THE BUREAU OF FOREST DEVELOPMENT, ORMOC CITY AGENCY; THE POLICE STATION COMMANDER, INP, ORMOC STATION; AND THE COMMANDING OFFICER, 352ND PC COMPANY FOR THE RELEASE OF THE CONFISCATED LUMBERS (20 PIECES 2X2X14; 40 PIECES 2X8X12) AT THE CUSTODY OF THE POLICE HEADQUARTERS, AND TO DONATE THE SAME TO BARANGAY ALTA VISTA FOR THE CONSTRUCTION OF ITS BARANGAY HALL AND HEALTH CENTER AND TO AUTHORIZE THE PUNONG BARANGAY TO ACCEPT THE SAID DONATION.

"WHEREAS, Alta Vista, being a newly created Barangay is in dire need of Barangay Hall and health center;

"WHEREAS, Barangay Alta Vista is a newly created Barangay has yet no 10% Realty Tax Share to finance the aforementioned projects;

"WHEREAS, on September 14, 1986, Sgt. Gonzalo and his team of the Ormoc City Police Station, confiscated lumbers from a certain Teodoro Piamonte residing at Barangay Visares, Capoocan, Leyte, at the junction of Dayhagan-Salvacion, the description of which are as follows: 20 pieces 2x8x14; 40 pieces 2x8x12, now under the custody of the Police Headquarters, this city;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded jointly by Kagawads Hermesilla and Subingsubing; be it


"RESOLVED, to request the Philippine National Oil Company (PNOC) based in Tungonan; the Bureau of Forest Development, Ormoc City Agency; the Police Station Commander, INP, Ormoc Station; and the Commanding Officer, 352nd PC Company, Camp Downes, for the release of confiscated lumbers (20 pieces 2x2x14; 40 pieces 2x8x12) in the custody of the Ormoc City Police Headquarters, and to donate the same to Barangay Alta Vista for the construction of its Barangay Hall and Health Center and to authorize the Punong Barangay to accept the said donation;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Project Manager/Officer-In-Charge, PNOC, Tungonan; the Bureau of Forest Development, Ormoc City Agency; the Police Station Commander, INP, Ormoc Station; and the Commanding Officer, 352nd PC Company, Camp Downes, all in Ormoc City.
