'Report on damaged parts of Toyota Land Cruiser bearing plate
No. HAG-248;

1. Hard top (fiber glass) was broken, needs replacement,
2. Right side window glass and right side corner glass were broken, need replacement,
3. 1 pcs - hanger w/ pin and bushing rear right, front, was defective, need replacement,
4. 2 pcs. - from shackle w/ pin and bushing were defective, need replacement,
5. 1 pc.- spring assy. front was defective, needs replacement,
6. 2 pcs. - tire w/ inner tube were defective, need replacement,
7. 1 pc. - signal light assy., front, was broken, needs replacement,
8. 2 pcs. - side mirror were broken, need replacement,
9. Right side body, door and fender were badly damaged, needs general repair and repainting w/ same color,
10. Bumper and chassis were disaligned. need repair and realignment,
11. Front seat frame defective, needs repair,
12. 1 unit - Car Stereo and antenna were defective, needs repair,
13. 1 pc. - Car stereo speaker was broken. needs replacement.
