RESOLUTION NO. 83

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR TO ACCEPT THE DONATION OF DOÑA FELIZA VDA DE MEJIA OF LOTS (ROAD LOT 1 OF THE SUBDIVISION PLAN, (LRC) PSD-234024, BEING A PORTION OF LOT I-M-27 DESCRIBED ON PLAN (LRC) PSD-226013, L.R.C. CAD. REC. NO. 1750); ROAD LOT 2, ROAD LOT 3 OF THE SAME SUBDIVISION PLAN; AND ROAD LOT 1 OF THE SUBDIVISION PLAN PSD-74379, BEING A PORTION OF LOT 5230-A DESCRIBED ON PLAN PSD-72975, L.R.C. REC. NO. ; ALL SITUATED AT COGON COMBADO, ORMOC CITY, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC.

"WHEREAS, the then Fifth Municipal Board of Ormoc City passed and approved Resolution No. 168 dated July 14, 1965, among others, approving the application for subdivision of Lot No. 5230-A, Psd-72975 of Mrs. Feliza Z. Vda de Mejia situated at Cogon Combado, this city, otherwise known as the Ormoc Heights Subdivision, as recommended by the City Engineer; considering that the subdivision owner has complied with the rules provided for in Subdivision Ordinance No. 51 under Resolution No. 142 dated May 26, 1965 as modified by Ordinance No. 6, under Resolution No. 67 dated April 13, 1972;

"WHEREAS, by virtue of said resolution the subdivision owner will have to donate all the Road lots as provided for on Ordinance No. 6 (Subdivision Ordinance);

"NOW, THEREFORE, on motion of Kagawad Salazar, seconded by Kagawad Subingsubing; be it

"RESOLVED, to authorize the Honorable Emeterio V. Larrazabal, OIC-City Mayor to accept the donation of Doña Feliza Vda de Mejia of Lots (Road Lot 1 of the Subdivision Plan, (LRC) Psd-234024, being a portion of Lot I-M-27 described on Plan (LRC) Psd-226013, L.R.C. Cad. Rec. No. 1750); Road Lot 2, Road Lot 3 of the same Subdivision Plan; and Road Lot 1 of the Subdivision Plan Psd-74379, being a portion of Lot 5230-A described on Plan Psd-72975, L.R.C. Rec. No. ; all situated at Cogon Combado, Ormoc City, for and in behalf of the City government of Ormoc;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Legal Officer, the City Treasurer, and Mrs. Feliza Vda de Mejia; all in Ormoc City;


