RESOLUTION NO. 90

A RESOLUTION AUTHORIZING THE HONDRABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF TWO (2) UNITS FLUORESCENT LAMPS OF BARANGAY ALEGRIA TO BE INSTALLED IN THE PREMISES OF SAID BARANGAY; ONE (1) UNIT AT POST ENTERING THE SLAUGHTERHOUSE COMPOUND; AND THE OTHER ONE (1) UNIT AT POST ALONG THE ALEGRIA ROAD TO BARANGAY PUNTA, INFRONT OF MR. PEDRO M. VELAYO'S HOUSE, SUBJECT TO RESOLUTION NO. 1149, DATED APRIL 20, 1982.

"WHEREAS, this august Body is in receipt of Resolution No. 6, Series of 1986 of the Sangguniang Pambarangay of Alegria donating to the City Government of Ormoc two (2) units fluorescent lamps to be installed in the following places: one (1) unit at post entering the Slaughterhouse compound; and the other one (1) unit at post along the Alegria road to Barangay Punta, infront of Mr. Pedro M. Velayo's house;

"NOW, THEREFORE, on motion of Kagawad Salazar, seconded by Kagawad Subingsubing; be it


