RESOLUTION NO. 91

A RESOLUTION STRONGLY PETITIONING HER EXCELLENCY, PRESIDENT CORAZON C. AGUID THROUGH THE HONORABLE MINISTER OF PUBLIC WORKS AND HIGHWAYS MINISTER ROGACIAND MERCADO, TO EXTEND THE SERVICES OF ENGR. BNEDICTO E. PEREZ, AS REGIONAL DIRECTOR OF MPWH, REGION VIII.

"WHEREAS, this august Body has been informed through the Secretary of OIC, Monorale Mayor Emeterio V. Larrazabal that the Regional Director of the Ministy of Public Works and Highways of Region VIII is due for retirement somtime in November this year:

"WHEREAS, considering the fact that the Province of Leyte particularly is City of Ormoc is undergoing continuous implementation of infrastrucire projects in order to answer the needs of the populace especially thom in the Minterlands, the City of Ormoc and the Province of Leyte and to Ministry of Public Works and Highways, Regional Office among the recipients of additional infrastructure fund releases undergoing its mplementation as agreed upon with the Ministry of Public Works and Highlys in consultative meetings with the Local Government;

"WHEREAS, uring this momentous period like the present in which we greatly volved in the task of nation building, a change or a replacement of me present Director of Region VIII would not only affect and jeopardizehe on-going and programmed projects but most likely it

will cause a lay in the implementation of infrastructure programs

considering the length of time needed and mandated for prientation and consultation with a new Regional Director;

"WHEREAS, the Ministry of Public Works and Highways of Region VIII under the leadership of Director Benedicto E. Perez pursued the monumental task and embarked upon its demands for success by issuing policies which jives with public sentiment and by establishing good rapaort among the local officials, his remarkable performance has won for him not only the plaudits of an appreciative public but also the respect and admiration of local officials;

"WHEREAS, the Members of this august Body during its pre-session caucus yesterday afternoon reflected its confidence and being convinced of Director Benedicto E. Perez proven competence, integrity, sincerity, honesty, efficiency, pious dedication, exemplary conduct and attitude, a qualification so desired to attain success and realization of the objectives, projects and programs of this region:

"WHEREAS, the Ministry of Local Bovernment is so concerned with the change of the Ministry of Public Works and Highways Director and for the same feeling of concern this august Body should justly support the retention of Director Perez as we have already established and instituted a good working relationship with him ever since and long enough to know and understand and carry on the implementations of a solution for the needs of the people and the problems at hand;

"NOW, THEREFORE, on motion of Kagawad Fiel, jointly seconded by Kagawads Yrastorza and Hermosilla; be it

"RESOLVED, to strongly petition Her Excellency, President Corazon C. Aquino through the Honorable Minister of Public Works and Highways, Minister Rogaciano Kercado to extend the services of Engr. Benedictor E. Perez, as Regional Director of MPWH, Region VIII;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Her Excellency, President Corazon C. Aquino, Malacanang, the Honorable Minister Rogaciano Mercado of the Ministry of Public Works and Highways, Intramuros, both in Metro Manila; and the Regional Director, Benedicto F. Perez of MPWH, Region VIII, Tacloban City;

"CARRIED. Seven affirmative votes and two abstentions registered by Kagawads Salazar and Suan;
