RESOLUTION NO. 92

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE BALANCE OF P1,000.00 BARANGAY DEVELOPMENT FUND OF BARANGAY NUEVA SOCIEDAD TO BE MADE AVAILABLE FOR BURIAL BENEFITS TO THE SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD ANTONIO R. UDTCHAN, WHO PASSED AWAY ON SEPTEMBER 23, 1986, AS MANDATED BY SEC. 94, PARAGRAPH (3) OF THE LOCAL GOVERNMENT CODE.

"WHEREAS, the Sangguniang Pambarangay of Nueva Sociedad in its Resolution No. 4, series of 1986 has appropriated the amount of P500.00 from out of any of its available funds to be made available for burial benefits to the surviving heirs of the Late Barangay Kagawad Antonio R. Udtchan, who died on September 23, 1986;

"WHEREAS, upon verification with the City Treasurer's Office the remaining balance of the 10% Realty Tax Barangay Share of Barangay Nueva Sociedad is only P97.00 not enough to serve the purpose;

"WHEREAS, this august Body has referred this matter to the City Budget Officer for source of funds and that in her second Indorsement the said request may be funded from out of the balance of P1,000.00 from Barangay Development Fund of Barangay Nueva Sociedad;


"NOW, THEREFORE, on motion of Kagawad Yrastorza, jointly seconded by Kagawads Salazar and Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the sum of FIVE HUNDRED PESOS (P500.00) from out of the balance of P1,000.00 Barangay Development Fund of Barangay Nueva Sociedad to be made available for burial benefits to the surviving heirs of the Late Barangay Kagawad Antonio R. Udtohan, who passed away on September 23, 1986, as mandated by Sec.94, Paragraph (3) of the Local Government Code;


"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the surviving heirs of the Late Antonio R. Udtohan and the Sangguniang Pambarangay of Nueva Sociedad, all in Ormoc City;

"CARRIED UNANIMOUSLY."


