RESOLUTION NO. 98

A RESOLUTION EARNESTLY REQUESTING THE ORMOC TELEPHONE COMPANY TO
IMPROVE AND REPAIR THE COMMUNICATION SERVICES AND FURTHER TO
REQUIRE THE SAID TELEPHONE COMPANY TO INSTALL A GENERATOR TO SERVE
AS STANDBY POWER IN CASE OF ELECTRIC POWER FAILURES FROM NATIONAL
POWER CORPORATION.

"WHEREAS, there has been numerous complaints from the Telephone
subscribers in Ormoc City in regards to the very poor service of the
Ormoc City Telephone Company;

"WHEREAS, these complaints have been aired very long time ago, as
the main clamor of the subscribers and users ever since the first year
of operation of said Telephone Company;

"WHEREAS, during the three days electric power failure of the
National Power Corporation aftermath of typhoon Pacing, the telephone
communication of the whole city bugged down and there was complete
black-out of telephone communication;

"WHEREAS, in as much as the residents of Ormoc especially the
commercial, agricultural and industrial sectors which for the past years
and until the present have become so dependent on telephone system for
communication, not only for commercial purposes but most especially for
calls during emergencies like fire and other incidents of crimes, it is
imperative that the telephone communication of the city should at all
times be in good order and condition for the protection of life and
property;

"NOW, THEREFORE, on motion of Kagawad Fiel, jointly seconded by
Kagawads Rivilla, Salazar and Subingsubing; be it

"RESOLVED, to earnestly request the Ormoc City Telephone Company to improve and repair the communication services and further to require the said Telephone Company to install a generator to serve as standby power in case of electric failures from the National Power Corporation;


