"WHEREAS, during the regular session on November 26, 1986, Kagawad Fiel sponsored a Resolution No. 124 reestablishing the barangay site of Barangay Danao and he requested the consensus of the august Body to have Barangay Danao be included in District III under his jurisdiction and Barangay Buenavista which is within the boundary of the Poblacion would be transferred to District I under the jurisdiction of the Honorable Vice-Mayor & Presiding Officer, Honorable Benjamin B.
