RESOLUTION NO. 147

A RESOLUTION AUTHORIZING THE CITY TREASURER TO SET ASIDE 2% RESERVED FUND TO BE MADE AVAILABLE FOR THE OPERATING EXPENSES OF THE CIVIL DISASTER COUNCILS OF ORMOC CITY;

"WHEREAS, this august body receives Memorandum Circular No. 86-16 dated June 23, 1986 from the MLG Acting Minister Honorable Douglas R. Cagas directing implementation of Section 5, P.D. 1566 re Organization and/or reorganization of provincial, municipal disaster coordinating councils, and immediate operation thereof;

"WHEREAS, Section 5, of P.D. 1566 provides that all heads of provincial, municipal government units are directed to organize and/or reorganize provincial, municipal barangay disaster coordinating councils in their respective local government units in conformance with the rules and regulation implementing the provision of P.D. No. 1566 strengthening the Philippine Disaster Control capability and establishing the national program on community disaster preparedness;

"WHEREAS, to make the local disaster coordinating councils immediately operational, all local government units are directed to make use of the 2% reserved fund earmarked for the purpose pursuant to Section 9 of said decree;

"NOW, THEREFORE, on motion of Kagawad Suan, jointly seconded by Kagawad Subingsubing and Rivilla; be it

"RESOLVED, to authorize the City Treasurer to set aside 2% reserved fund to be made available for the operating expenses of the Civil Disaster Councils in Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Honorable Douglas R. Cagas, MLG Acting Minister, Quezon City, the City Budget Officer, the City Treasurer and the Senior Local Government Officer, MLG, both in Ormoc City;

"CARRIED UNANIMOUSLY."
