RESOLUTION NO. 148

A RESOLUTION AUTHORIZING THE HONORABLE DIC-MAYOR EMETERIO V. LARRAZABAL TO EXTEND THE DEADLINE FOR THE CITY MAYOR'S PERMIT AND CITY LICENSE FEES PAYMENT FROM JANUARY 20 TO FEBRUARY 15, 1987.

"WHEREAS, the deadline for payment of Mayor's Permit and City License fees is January 20, 1987 and quite a number of taxpayers not to mention the Ormoc Filipino Retailers' Association have made representations for its extension even just to the end of the month to give them more than ample time to meet the various requirements such that we find it quite proper to temporarily suspend the operation of Section 2.1.4 of Tax Ordinance No. 1, otherwise known as the 'Ormoc City Revenue Code of 1977', fixing the first twenty (20) days of January to pay tax obligations;

"RESOLVED, to authorize the Honorable DIC-City Mayor Emeterio V. Larrazabal to extend the deadline for payment of Mayor's Permit and City License fees from January 20 to February 15, 1987;
