RESOLUTION NO. 149

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL HOUSING AUTHORITY AND ITS IMPLEMENTING ARM THE HOUSING & URBAN DEVELOPMENT COORDINATION COUNCIL TO GIVE DUE COURSE TO THE LETTER-REQUEST OF MRS. PURA CATINGUB FIEL FOR THE SALE OF 20,316 SQUARE METERS FOR URBAN DEVELOPMENT PROJECT IN THE CITY OF ORMOC.

"WHEREAS, this august Body is in receipt of a communication dated January 19, 1987 of Mrs. Pura Catigub Fiel, among, others, offering for sale to the City Government of Ormoc 20,316 square meters residential lot situated at Barangay Punta, this city at P200.00 per square meters;

"WHEREAS, by virtue of Executive Order No. 90, the Housing & Urban Development Coordination Council (HUDCC) was created as the implementing arm of the National Housing Authority, which is responsible in giving attention on urban development especially housing problems which are their mean concern;

"WHEREAS, the National Housing Authority has set aside P4M earmarked for this purpose;

"WHEREAS, it is the Housing & Urban Development Coordination Council (HUDCC) who conducts an ocular inspection and determine the price of the land to be purchased and no less than 815 people of Ormoc will be benefited if this project will soon be realized.

"NOW, THEREFORE, on motion of Kagawad Salazar, jointly seconded by Kagawad Subingsubing and Hermosilla; be it

"RESOLVED, to earnestly request the National Housing Authority and its implementing arm the Housing and Urban Development Coordination Council (HUDCC) to give due course to the letter-request of Mrs. Pura Catigub Fiel for the sale of 20,316 square meters for urban development project in Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the General Manager, National Housing Authority; Manila, the City Engineer and Mrs. Pura C. Fiel, both in Ormoc City;
