RESOLUTION NO. 151

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF FIVE HUNDRED PESOS (P500.00) FROM OUT OF THE 10% BARANGAY SHARE OF KADAQHAN TO BE MADE AVAILABLE FOR BURIAL BENEFITS TO THE SURVIVING SPOUSE AND LEGAL HEIRS OF THE LATE BARANGAY KALIHIM PEDRO T. CABALLERO, WHO DIED ON DECEMBER 27, 1986.

"WHEREAS, the Sangguniang Pambarangay of Kadaohan in its Resolution No. 1 Series of 1987 has requested to appropriate the amount of Five Hundred Pesos (P500.00) to be paid to the surviving spouse and legal heirs of the late Pedro T. Caballero, Kalihim ng Barangay of Barangay Kadaohan, who died last December 27, 1986;

"WHEREAS, Section 94, Paragraph 3 of Batas Pambansa 337, mandates that the surviving spouse or legal heirs of every barangay officials who dies during his incumbency shall be entitled to burial benefits chargeable against the general fund of the barangay in an amount not less than five hundred pesos. In the event the barangay funds are insufficient for this purpose, the same shall be chargeable against the funds of the city or municipality to which the barangay belongs;

"AND, THEREFORE, on motion of Kagawad Yrastorza, seconded by Kagawad Hermosilla; be it

"RESOLVED, to authorize the City Treasurer to release the sum of Five Hundred Pesos (P500.00) from out of the 10% barangay share of Kadaohan to be made available for burial benefits to the surviving spouse and legal heirs of the late Barangay Kalihim Pedro T. Caballero, who died on December 27, 1986;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the surviving spouse and legal heirs of the late Pedro T. Caballero, and the Sangguniang Pambarangay of Kadaohan, all in Ormoc City;

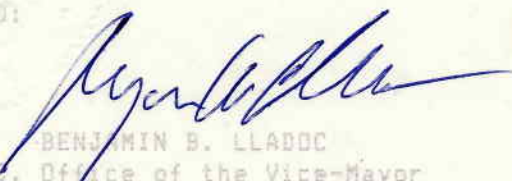
