A RESOLUTION REQUESTING THE LEYECO V FOR INSTALLATION OF ELECTRIC POWER LINES TO BARANGAY QUEZON, JR., ORMOG CITY.

"WHEREAS, we receive Resolution No. 1, dated January 2, 1987 of the Sangguniang Pambarangay of Quezon, Jr. earnestly requesting the City Mayor to intercede with the Management of Leyeco V, this city, for installation of electric power lines to Barangay Quezon, Jr.;

"WHEREAS, said resolution states the if said power lines are installed, it will not only help the residents unmeasurably, but the national government as well because up to the present, the constituents are using fossil fuels for their lighting purposes which drains the national coffers due to the high and prohibitive cost of fuel oils;

"WHEREAS, with the installation of electric lines to the barangay, the residents believe that it may usher in the entrance of home industries which may avail of cheap electrical power to run tools which may help alleviate the current unemployment problem and economic stalemate;

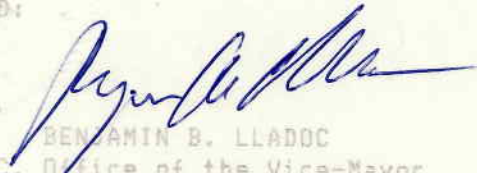
