RESOLUTION NO. 154

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF TWELVE (12) UNITS FLUORESCENT LIGHTING FIXTURES COMPLETE WITH ACCESSORIES TO BE INSTALLED AT BARANGAY PATAG, THIS CITY, SUBJECT TO RESOLUTION NO. 1149 DATED APRIL 20, 1982, LIMITING BARANGAY ELECTRIC CURRENT TO 250 WATTS, OTHERWISE ANY EXCESS OF WATTAGE WILL BE PAID BY THE BARANGAY OUT OF THEIR 10% REALTY TAX SHARES.

"WHEREAS, this august body receives Resolution No. 2, Series of 1987 of the Sangguniang Pambarangay of Patag, donating to the City Government of Ormoc twelve (12) units fluorescent lighting fixtures 20-watt, 220-volts, complete with weather protector (galvanized) and mounting brackets (galvanized) with lead out wires, and earnestly and respectfully requesting His Honor Emeterio V. Larrazabal, through the Honorable Members of the Sangguniang Panlungsod, to accept the said donation and to cause the City Treasurer's Office to pay the electric power consumption of said lighting fixtures;

"WHEREAS, as stated in said resolution the Sangguniang Pambarangay of Barangay Patag passed unanimously Resolution No. 1 and Ordinance No. 1 both series of 1987, appropriating certain amount in purchasing 12 units fluorescent lighting fixtures to be installed at strategic places of Barangay Patag;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Kagawad Yrastorza; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal to accept, in behalf of the City Government of Ormoc the donation of twelve (12) units fluorescent lighting fixtures complete with accessories to be installed at the strategic places at Barangay Patag, this city, subject to Resolution No. 1149 dated April 20, 1982 limiting barangay electric current to 250 watts, otherwise any excess of wattage will be paid by the barangay out of their 10% Realty Tax Shares;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the Leyeco V and the Sangguniang Pambarangay of Patag, all in Ormoc City
