RESOLUTION NO. 155

A RESOLUTION AUTHORIZING THE HONORABLE DIC-MAYOR, IN BEHALF OF THE CITY OF ORMOG TO EXECUTE A DEED OF DONATION WITH THE PHILIPPINE COAST GUARD OVER 400 SQUARE METERS LOT ALREADY ALLOTTED TO THEM PURSUANT TO RESOLUTION NO. 1157, DATED MAY 11, 1982 OF THE SECOND SANGGUNIANG PANLUNGSOD NG ORMOG PROVIDED THAT SHOULD THE PCG NO LONGER USE THE SITE DONATED, THE SAME SHALL BE IMMEDIATELY RETURNED TO THE CITY GOVERNMENT, INCLUDING ALL IMPROVEMENTS THEREON.

"WHEREAS, the then Second Sangguniang Panlungsod ng Ormog passed and approved Resolution No. 1157 approving the establishment of the Philippine Coast Guard Headquarters on a portion of lot between the Philippine Ports Authority Office and the Ormog pier at the shore protection development area fronting the Bus Terminal No. 2;

"WHEREAS, a survey conducted by the City Engineer's Office was already approved and the area of 400 square meters was allotted to the Philippine Coast Guard, however, the Second Sangguniang Panlungsod ng Ormog failed to authorize the Mayor to execute a Deed of Donation as required by the Philippine Coast Guard in Manila in order that fund for the establishment of the PCG Headquarters could be released soon;

"NOW, THEREFORE, on motion of Kagawad Suan, seconded by Kagawad Subingsubing; be it

"RESOLVED, to authorize the Honorable Emeterio V. Larrazabal, DIC-Mayor, for and in behalf of the City Government of Ormog to execute a Deed of Donation with the Philippine Coast Guard over 400 square meters lot already allotted to them, pursuant to Resolution No. 1157 dated May 11, 1982 of the Second Sangguniang Panlungsod ng Ormog, provided that should the PCG no longer use the site donated, the same shall be immediately returned to the City Government, including all improvements thereon;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Philippine Coast Guard, Manila; through the Philippine Coast Guard, Ormoc Sub-Station, Ormoc City;
