A RESOLUTION REQUESTING THE MANAGEMENT OF LEYECO V FOR INSTALLATION
OF POWER LINES TO BARANGAY HIBUNAON, THIS CITY.

"WHEREAS, the Sangguniang Pambarangay of Hibunaon has urgently and respectfully solicited the intercession of the Honorable DIC-City Mayor Emeterio V. Larrazabal, to request the Management of Leyeco V for the installation of power lines to their barangay;

"WHEREAS, Resolution No. 1, states that many constituents have expressed their urgent desire to avail of electric power in order to get rid once and for all the costly purchase of fuel oils and to have ready for use of several barangay residents the electric power to run electrical tools which may be purchased in order to beat the problem of unemployment within the barangay;

RESOLVED, to request the Management of Leyeco V to install electric power lines to Barangay Hibunaon, this city;
