



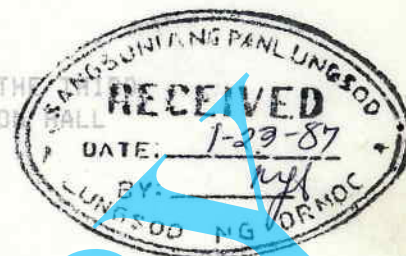

"RESOLVED, FINALLY, to furnish a copy of this resolution to Her Excellency, President Corazon C. Aquino, Malacanang, Metro Manila;

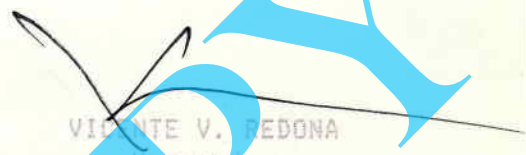
