RESOLUTION NO. 159

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR PORFERIO P. SLAYNGCO OF THE LOCAL GOVERNMENT TO GRANT AUTHORITY TO UTILIZE AN AMOUNT OF EIGHTY THOUSAND (P80,000.00) FROM THE 20% ECONOMIC DEVELOPMENT FUND FOR MEALS AND TRANSPORTATION ALLOWANCE IN THE CONDUCT OF INFORMATION DRIVE REGARDING THE RATIFICATION OF THE DRAFT CONSTITUTION.

"WHEREAS, Plebiscite is scheduled on February 2, 1987 for the ratification of the constitution;

"WHEREAS, it is imperative to set aside an amount of Eighty thousand Pesos (P80,000.00) to cover the expenses for meals and transportation allowance in the conduct of information drive regarding the ratification of the draft constitution;

"NOW, THEREFORE, on motion of Kagawad Redona, seconded by Kagawad Salazar; be it

"RESOLVED, to earnestly request the Regional Director Porferio P. Slayngco of the Local Government to grant authority to utilize an amount of Eighty Thousand Pesos (P80,000.00) from the 20% Economic Development Fund for meals and transportation allowance in the conduct of information drive regarding the ratification of the draft constitution;

"RESOLVED, FURTHER, to furnish copy of this resolution to Honorable Porferio P. Slayngco, Regional Director, Ministry of Local Government, Tacloban City for his consideration and approval;

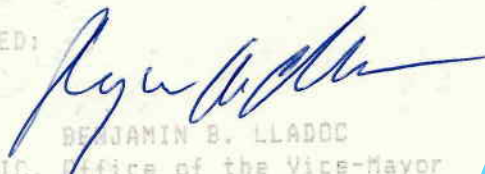

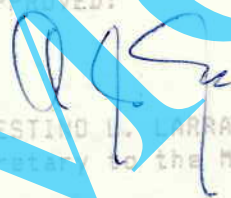
