RESOLUTION NO. 160

A RESOLUTION AUTHORIZING THE HONORABLE DIC, CITY MAYOR EMETERIO V. LARRAZABAL TO ENTER INTO A NEGOTIATED CONTRACT WITH A PRIVATE CONTRACTOR FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORmoc REGARDING THE ALTA VISTA-SUMANGGA-BANTIGUE AND IPIL (ASBI) PROJECT IN THE AMOUNT OF FIVE MILLION PESOS (P5,000,000.00).

"WHEREAS, the Honorable DIC-City Mayor Emeterio V. Larrazabal has endorsed the communication of the Ex-Officio City Development Coordinator, City Planning and Development Office, which is hereunder quoted verbatim, to wit:

"Sir,

"This is in connection with my recent trip to Manila to follow-up the necessary papers re: our proposed Alta Vista-Sumangga-Bantigue-Ipil (ASBI) waterworks system.

"The amount of P5,000,000.00 has already been allotted per letter of Mr. Romualdo S. Mondejar, Jr., Project Manager, BWP to your Office dated January 19, 1987. However, we are only given up to January 31, 1987, to submit the contract.

"It was suggested that the proposed project be undertaken by negotiated

contract as there will be no more time for a public bidding. The following papers are needed in this connection:

"1) A resolution of the Hon. Sangguniang Panlungsod authorizing the Hon. City Mayor to enter into contract regarding the ASBI project in the amount of P5,000,000.00; and

"2) A letter of request by the Hon. City Mayor to the Hon. Minister Jaime Ferrer of the Ministry of Local Government authorizing the City Mayor to enter into contract regarding the same project.

"It is hoped that the said papers be prepared soonest before the January 31 deadline."

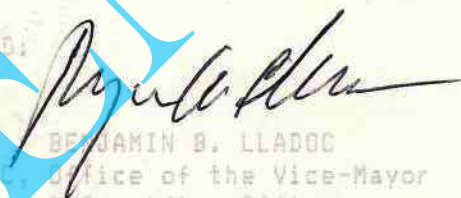

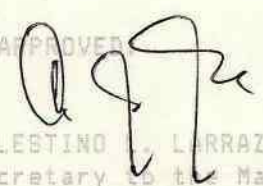
