RESOLUTION NO. 163

A RESOLUTION REQUESTING THE LAND TRANSPORTATION COMMISSIONER, COL. MARIANO SANTIAGO TO FURNISH THIS BODY CERTIFIED XEROX COPIES OF PROVISIONAL AUTHORITIES ISSUED TO BACHELOR EXPRESS INC. AND VALLACAR TRANSIT INC. TO OPERATE PUB SERVICE ON DAVAO-ORMOC ROUTE AND VICE-VERSA; CAGAYAN DE ORO - ORMOC ROUTE AND VICE-VERSA; SURIGAO-ORMOC ROUTE AND VICE-VERSA; AND DAVAO-TACLOBAN ROUTE AND VICE-VERSA.

"WHEREAS, the Committee on Transportation and Communication has been in receipt of complaints from the local PUB Operators regarding the operation in Ormoc City of the Bachelor Express Inc., which according to them is operating illegally since they failed to present a certified true xerox copy of the authority to operate in Ormoc;

"WHEREAS, the Regional Office of the Land Transportation Commission and the Ormoc City Land Transportation Commission Agency was not furnished a copy of the franchise or provisional authority which is supposed to be the standard procedure;

"WHEREAS, the local operators are complaining that the said Bachelor Express Inc. buses are cutting trips and do not proceed to their alleged route from Mindanao island to Leyte island and vice-versa;

"WHEREAS, in order to clarify matters and solve the problem confronting this Committee in regards to operation and control of Public Conveyance in our city especially at the Bus Terminal Area;

"NOW, THEREFORE, on motion of Kagawad Fiel, jointly seconded by Kagawad Rivilla and Hermosilla; be it

"RESOLVED, to request the Land Transportation Commissioner, Col. Mariano Santiago to furnish this Body certified xerox copies of the provisional authorities issued to Bachelor Express Inc. and Vallacar Transit Inc. to operate PUB Service on Davao-Ormoc route and vice-versa;

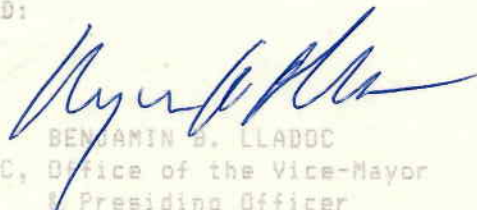

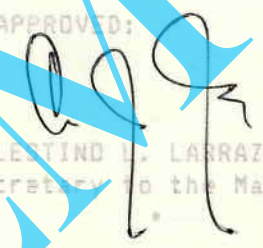
