"WHEREAS, Resolution No. 1 dated July 15, 1986 of the Sangguniang
Pambarangay of Juaton has requested the Sangguniang Panlungsod ng Ormoc
through the Honorable DIC-Mayor Emerio V. Larrazabal to pass
a resolution requesting Leyeco V to install electric lines in Purok 1,
Barangay Juaton, this City;

"WHEREAS, the Barangay Juaton residents desire to have installed
electric lights on their respective houses, requested the Sangguniang
Pambarangay of said barangay to make representation with the Honorable
Sangguniang Panlungsod ng Ormoc so that their problem can be heard and
soon be realized;

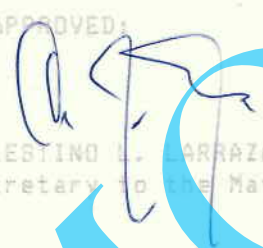
