RESOLUTION NO. 166

A RESOLUTION EXPRESSING OUR APPRECIATION AND GRATITUDE TO THE SCHOOL TEACHER MEMBERS OF THE BOARD OF ELECTION INSPECTORS FOR THEIR HELP IN CONDUCTING A CLEAN, HONEST AND ORDERLY PLEBISCITE AND MOST ESPECIALLY TO THE PEOPLE OF ORMOC FOR THEIR ADMIRABLE SUPPORT FOR THE RATIFICATION OF THE NEW CONSTITUTION WITH THE PURPOSE OF ESTABLISHING POLITICAL STABILITY, NORMALCY AND ECONOMIC RECOVERY, AND AFFIRMING THE LEADERSHIP OF HER EXCELLENCY PRESIDENT CORAZON C. AQUINO AND THE LOCAL OFFICIALS OF ORMOC.

"WHEREAS, according to observation by this august Body the recently concluded February 2, 1987 Plebiscite was the biggest turn out of voters and the referendum exercise was conducted in a very smooth, clean, honest and orderly manner and the people voted and supported for the new Constitution in a very big majority vote. They gave 86% YES vote in Ormoc City and despite of the misleading information disseminated by the campaigners of the NO vote the people were not dissuaded, instead they remained unwavering in their support for a just and noble cause;

"WHEREAS, the results of the Plebiscite indubitably showed the great trust and confidence reposed by the good people of Ormoc in the leadership of our beloved Her Excellency President Corazon C. Aquino and of His Honor, OIC-City Mayor Emeterio V. Larrazabal;

"NOW, THEREFORE, on motion of Kagawad Fiel, unanimously seconded;

"RESOLVED, to express our appreciation and gratitude to the School Teacher Members of the Board of Election Inspectors for their help in conducting a clean, honest and orderly Plebiscite and most especially to the people of Ormoc for their support for the ratification of the new Constitution with the purpose of establishing political stability, normalcy and economic recovery, and affirming the leadership of Her Excellency President Corazon C. Aquino and the local officials in

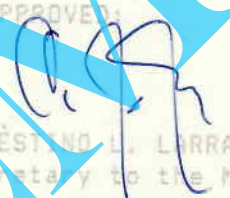
