RESOLUTION NO. 170

A RESOLUTION APPROPRIATING FOUR HUNDRED THIRTY-TWO PESOS & 14/100 (P432.14) FROM WHATEVER FUNDS AVAILABLE IN THE CITY TREASURY TO ADD TO THE REMAINING 10% SHARE OF BARANGAY TUNGONAN IN THE AMOUNT OF P67.86 TO COMPLETE THE P500.00 TO BE MADE AVAILABLE FOR BURIAL BENEFITS TO THE SURVIVING SPOUSE AND LEGAL HEIRS OF THE LATE BARANGAY KAGAWAD PASTOR S. ALAD.

"WHEREAS, this august Body is in receipt of the Resolution No. 1, series of 1987 of the Sangguniang Pambarangay of Tungonan appropriating from out of its existing barangay funds in the amount of P500.00 to be paid to the surviving spouse or legal heirs of the late Barangay Kagawad Pastor S. Alad, who expired February 6, 1987;

"WHEREAS, Sec. 24, Paragraph (3) of the Local Government Code (Batas Pambansa 337) mandates that during his incumbency shall be entitled to burial benefits chargeable against the General Fund of the barangay in an amount not less the Five Hundred Pesos. In the event the barangay funds are insufficient for this purpose, the same shall be chargeable against the funds of the city or municipality to which the barangay belongs;

"WHEREAS, when said resolution was presented to the City Treasurer the same was not honored because the 10% barangay share left of Barangay Tungonan is only P67.86 and would not be enough for the purpose;

"NOW THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Yrastorza; be it

"RESOLVED, to appropriate the amount of Four Hundred Thirty-Two Pesos & 14/100 (P432.14) from whatever funds available in the City Treasury to add to the remaining 10% share of Barangay Tungonan in the amount of P67.86 to complete the P500.00 said sum or so much thereof as may be necessary to be made available for burial benefits to the

surviving spouse and legal heirs of the late Barangay Kagawad Pastor S. Alao, who passed away last February 6, 1987;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the City Budget Officer, the surviving spouse and legal heirs of the late Barangay Kagawad Pastor S. Alao and the Sangguniang Pambarangay of Tungonan, all in Ormoc City;

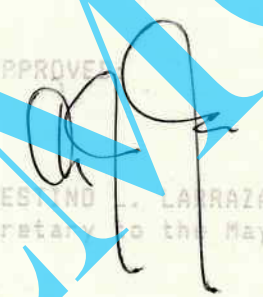
