RESOLUTION NO. 171

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC TO SIGN A DEED OF ABSOLUTE SALE WITH MRS. PURA C. FIEL, COVERING SIX THOUSAND AND FORTY ONE (6,041) SQUARE METERS OF THE LATTER'S LOT NO. 2269-J, SITUATED AT BARANGAY PUNTA ALONG NARRA AND BATICULIN CITY STREETS AT THE RATE OF P70.00 PER SQUARE METER AS APPRAISED BY THE ASSESSMENT DEPARTMENT BASED ON THE SCHEDULE OF MARKET VALUES OBTAINING IN 1978;

"WHEREAS, this august body is in receipt of the road-right-of-way claim of Mrs. Pura C. Fiel, covering 6,041 square meters of her Lot No. 2269-J, situated at Barangay Punta along Narra and Baticulín City streets, which was appraised by the Office of the City Assessor at the rate of P70.00 per square meter, based on the Schedule of Market Values obtaining in 1978;

"WHEREAS, the City Engineer in his indorsement dated February 5, 1987 has informed that the area used by the city government is 6,041 square meters more or less, situated along Narra and Baticulín city streets and further recommended that Mrs. Pura C. Fiel be given just compensation for her lot;

"NOW, THEREFORE, on motion of Kagawad Salazar, seconded by Kagawad Subingsubing; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal, for and in behalf of the City Government of Ormoc to sign a Deed of Absolute Sale with Mrs. Pura C. Fiel covering 6,041 square meters of the latter's Lot No. 2269-J, situated at Barangay Punta along Narra and Baticulín streets at the rate of P70.00 per square meter as appraised by the Assessment Department based on the Schedule of Market Values obtaining in 1978;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Engineer, the City Treasurer, the City Assessor, the City Budget Officer, and Mrs. Pura C. Fiel, all in Ormoc City;

CARRIED. Eight affirmative votes, one abstension registered by Kagawad Fiel.
