RESOLUTION NO. 173

A RESOLUTION AMENDING RESOLUTION NO. 151, SERIES OF 1987 OF THIS
AUGUST BODY SO AS TO APPROPRIATE THE AMOUNT OF THREE HUNDRED
THIRTY-EIGHT PESOS 1797.00 (P338.79) FROM WHATEVER FUNDS AVAILABLE
IN THE CITY TREASURER TO ADD TO THE REMAINING 10% SHARE OF BARANGAY
KADAHAN IN THE AMOUNT OF P161.21 TO COMPLETE THE P500.00 TO BE
MADE AVAILABLE FOR BURIAL BENEFITS TO THE SURVIVING SPOUSE AND
LEGAL HEIRS OF THE LATE KALIHIM PEDRO T. CABALLERO.

"WHEREAS, on January 21, 1987 this august Body passed and approved
Resolution No. 151, series of 1987, authorizing the City Treasurer to
release the sum of P500.00 from out of the 10% Barangay share of
Kadahan to be made available for burial benefits to the surviving spouse
and legal heirs of the late Barangay Kalihim Pedro T. Caballero, who
died on December 27, 1986;

"WHEREAS, 10% barangay share can be released through barangay
resolution only;

"WHEREAS, Sec. 94, Paragraph (3) of the Local Government Code
(Batas Pambansa 337) mandates that the surviving spouse or legal heirs
of every barangay officials who dies during his incumbency shall be
entitled to burial benefits chargeable against the general fund of the
barangay in an amount not less than Five Hundred Pesos. In the event
the barangay funds are insufficient for this purpose the same shall be
chargeable against the funds of the city or municipality to which the
barangay belongs;

"WHEREAS, the remaining 10% barangay share left of Barangay
Kadahan is only P161.21 and would not be enough for the purpose;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded
by Kagawad Sumaljag and Rivilla; be it

(RES. NO. 173)

"RESOLVED, to amend Resolution No. 151, series of 1987 of this august Body so as to appropriate the amount of Three Hundred Thirty-Eight Pesos & 79/100 (P338.79) from whatever funds available in the City Treasurer to add to the remaining 10% share of Barangay Kadaohan in the amount of P161.21 to complete the P500.00 to be made available for burial benefits to the surviving spouse and legal heirs of the late Barangay Kalihim Pedro T. Caballero, who died on December 27, 1987;

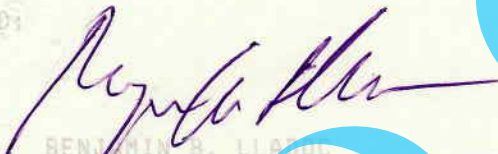
