RESOLUTION NO. 177

A RESOLUTION AUTHORIZING THE HONORABLE DIC-CITY MAYOR EMETERIO V. LARRAZABAL TO CAUSE THE INSTALLATION OF ELECTRIC BULBS ON THE PLACES INDICATED THEREIN ALONG THE MAIN ROAD OF BARANGAY ALEGRIA UP TO THE ALEGRIA-PUNTA BOUNDARY.

"WHEREAS, Resolution No. 1, series of 1987 of the Sangguniang Pambarangay of Alegria has requested the Honorable DIC-Mayor, through this august Body to install mercury bulbs on post without lights along the main road of Alegria up to the Alegria-Punta boundary;

"WHEREAS, this august Body finds the request very reasonable considering that the main purpose of which is for the smooth operation of the barangay government and for the good of public service;

"NOW, THEREFORE, on motion of Kagawad Salazar, jointly seconded by Kagawad Sumaljag and Subingsubing; be it

"RESOLVED, to authorize the Honorable DIC-City Mayor Emeterio V. Larrazabal to cause the installation of electric bulbs up to the Alegria-Punta boundary, indicated as follows:


- One (1) on post near the corner of the road going to the Slaughterhouse or near Lim's residence;
- One (1) on post near or in front Aguirre's residence;
- One (1) on post in front of Arar's residence; and
- One (1) on post in front of Vilayo's residence.




