RESOLUTION NO. 180

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR PORFERIO P. SIAYNGCO OF THE LOCAL GOVERNMENT, TACLOBAN CITY TO GRANT AUTHORITY TO UTILIZE THE AMOUNT OF TWENTY-FOUR THOUSAND THREE HUNDRED PESOS (P24,300.00) FROM THE 20% ECONOMIC DEVELOPMENT FUND FOR MEALS AND OTHER EXPENSES OF BARANGAY OFFICIALS OF ORMOC CITY FOR A ONE-DAY SEMINAR WITH SECRETARY NEPTALI GONZALES OF DEPARTMENT OF JUSTICE, ON SATURDAY, MARCH 7, 1987.

"WHEREAS, no less than the Honorable Neptali Gonzales, Secretary of Justice will be coming here in Ormoc City to conduct a one-day seminar for barangay officials of Ormoc City on Saturday, March 7, 1987;

"WHEREAS, in order to make this undertaking possible it is imperative to chip in an amount to defray the expenses like meals and snacks for the purpose;

"NOW, THEREFORE, on motion of Kagawad Redona seconded by Kagawad Fiel; be it


"RESOLVED, to earnestly request the Regional Director Porferio P. Siayngco of the Local Government, Tacloban City, to grant authority to utilize the amount of TWENTY-FOUR THOUSAND THREE HUNDRED PESOS (P24,300.00) from out of the 20% Economic Development Fund to be made available for meals and other expenses of barangay officials of Ormoc City for a one-day seminar with Secretary Neptali Gonzales of Department of Justice, on Saturday, March 7, 1987;


