RESOLUTION NO. 184

A RESOLUTION CREATING A SPECIAL COMMITTEE TO TREAT THE REQUEST OF ENGINEER YOSHIYUKI KOTAKE TO BE COMPOSED OF ONE REPRESENTATIVE EACH FROM THE OFFICE OF THE CITY MAYOR, FROM THE CITY TREASURER'S OFFICE, FROM THE CITY ENGINEERING, FROM THE OFFICE OF THE CITY PLANNING AND THREE FROM THE SANGGUNIANG PANLUNGSOD, ONE OF WHOM SHALL BE THE HONORABLE CHAIRMAN ON MARKET & SLAUGHTERHOUSES.

"WHEREAS, this august Body is in receipt of the 1st indorsement of the Honorable Officer-in-charge Mayor Emeterio V. Larrazabal, for appropriate action, the request of Engr. Yoshiyuki Kotake, in behalf of their group, composed of employees from the West Leyte Improvement Project asking permission to avail of the space occupied by the abandoned and dilapidated Public Market Building, located at our downtown area on a monthly rental basis, to give way, if granted to the construction of a semi-permanent building which they intend to use as a club house, with the option to utilize the same for other purposes compatible with the city zoning and land use and within the limitations and restrictions to be imposed by the Office of the City Mayor;

"WHEREAS, it is apparent that a Special Committee be created to study and treat the matter seriously in order to arrive at a very favorable and advantageous solution to both parties;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, seconded by Kagawad Hermosilla; be it

"RESOLVED, to create a Special Committee to treat the request of Engineer Yoshiyuki Kotake to be composed of one representative each from the Office of the City Mayor, from the City Treasurer's Office, from the City Engineering, from the Office of the City Planning and three from the Sangguniang Panlungsod, one of whom shall be the Honorable Chairman on Market & Slaughterhouses;
