RESOLUTION NO. 189

A RESOLUTION AUTHORIZING THE HONORABLE OIC-CITY MAYOR EMETERIO V. LARRAZABAL, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC TO SIGN A DEED OF ABSOLUTE SALE OF ROAD-RIGHT-OF-WAY WITH MRS. ENRICA YBANEZ, COVERING TWENTY-NINE (29) SQUARE METERS OF THE LATTER'S LOT NO. 1638, SITUATED AT BARANGAY ALEGRIA AT THE RATE OF P25.00 PER SQUARE METER, PURSUANT TO RESOLUTION NO. 9, DATED MAY 29, 1986.

"WHEREAS, this august Body passed and approved Resolution No. 9 dated May 28, 1986 for the payment of the road-right-of-way of Lot No. 1638 containing an area of 29 square meters in the amount of P725.00 to Mrs. Enrica Ybanez, but through oversight and inadvertence we forgot to incorporate in the resolution the phrase authorizing the OIC, City Mayor to sign the Deed of Sale in behalf of the city;

"NOW, THEREFORE, on motion of Kagawad Salazar, jointly seconded by Kagawads Suan, Subingsubing and Sumaljag; be it

"RESOLVED, to authorize the Honorable OIC-City Mayor Emeterio V. Larrazabal, for and in behalf of the City Government of Ormoc to sign a Deed of Absolute Sale of Road-Right-of-Way with Mrs. Enrica Ybanez, covering Twenty-Nine (29) square meters of the latter's Lot No. 1638, situated at Barangay Alegria at the rate of P25.00 per sq. meter, pursuant to Resolution No. 9, dated May 28, 1986.
