A RESOLUTION REQUESTING ENGINEER DOMETILIO SILVA, AREA EQUIPMENT ENGINEER TO DONATE TO THE ORMOC CITY TECHNOLOGICAL, MANPOWER TRAINING AND RESEARCH CENTER WHATEVER JUNKED VECHICLES AVAILABLE TO BE USED BY THE ORMOC CITY TECHNOLOGICAL, MANPOWER TRAINING AND RESEARCH CENTER TRAINING PROGRAMS.

"WHEREAS, the then Second Sangguniang Panlungsod ng Ormoc passed and approved Ordinance No. 27, embodying Resolution No. 933, on February 10, 1981, among others establishing a Technological, Manpower Training and Research Center in Ormoc City;

"WHEREAS, this center needs vehicles for the technical training of students:

"WHEREAS, it is imperative to ask Engr. Dometilio Silva to donate junked vehicles to the Ormoc City Technological, Manpower Training and Research Center for the discharge of their duties as the sole city government agency which shall be responsible for training, research and development under the unified-effort scheme;
