RESOLUTION NO. 191

A RESOLUTION EARNESTLY REQUESTING THE ASSISTANCE OF THE NATIONAL BUREAU OF INVESTIGATION IN ORDER THAT THE CRIME OF MURDER OR THE ASSASSINATION OF THE LATE BARANGAY CAPTAIN JACINTO S. COGAY OF BARANGAY SAN JUAN, ORMOC CITY, BE FINALLY SOLVED.

"WHEREAS, The late honorable Jacinto S. Cogay was shot dead while he was asleep by an unidentified assassins on the evening of December 28, 1986 in his residence at Barangay San Juan, Ormoc City;

"WHEREAS, Mrs. Lilia B. Cogay, widow of the late Jacinto S. Cogay in her letter dated March 18, 1987, has requested to intercede for the investigation of her husband's murder as she can not afford to pay private detectives to have the investigation of the case facilitated;

"WHEREAS, the widow of the victim has been disgusted with the Police Contingent investigating the case and they have not taken any further positive action on the part of the police;

"WHEREAS, apparently immediately after the incident there were persons picked up supposed to be suspected by the police but it turned out that after proper investigation they were not actually involved;

"WHEREAS, it behooves on this august Body to help the widow of the late public official to seek the assistance of the National Bureau of Investigation to facilitate the successful solution of the case, in fairness to the widow;

"NOW, THEREFORE, on motion of Kagawad Sumaljag, jointly seconded by Kagawad Hermosilla and Subingsubing; be it




