RESOLUTION NO. 194

A RESOLUTION AUTHORIZING THE HONORABLE DIC-CITY MAYOR EMETERIO V. LARRAZABAL TO ACCEPT THE DONATION OF BARANGAY AIRPORT OF FIVE (5) SETS OF FLUORESCENT LIGHTING FIXTURES, 20 WATTS, 220 VOLTS, COMPLETE WITH WEATHER PROTECTORS AND MOUNTING BRACKETS AND LEAD OUT WIRES; THE POWER CONSUMPTION AS REQUESTED BE BORNE BY THE CITY, SUBJECT, HOWEVER, TO RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, Resolution No. 3, Series of 1987 of the Sangguniang Pambarangay of Airport, among others, state that Barangay Airport had purchased five (5) sets Fluorescent Lighting Fixtures, 20-watt, 220 volt with weather protectors and mounting brakets and lead out wires to be donated to the city government of Ormoc with the request that the power consumption be borne by the city government;

"NOW, THEREFORE, on motion of Kagawad Suan, jointly seconded by Kagawad Rivilla, Subingsubing and Hermosilla; be it

"RESOLVED, to authorize the Honorable DIC-City Mayor Emeterio V. Larrazabal to accept the donation of Barangay Airport of five (5) sets of Fluorescent Lighting Fixtures, 20 watts, 220 volts, complete with weather protectors and mounting brakets and lead out wires and the power consumption as requested be borne by the city, Subject, However, to Resolution No. 1149 dated April 20, 1982.


"RESOLVED, FURTHER, to furnish a copy of this resolution each to the City Treasurer, the Leyeco V, and the Sangguniang Pambarangay of Airport, all in Ormoc City;
